ELIGIBILITY: All athletes must be a resident of the United States and a current NPC cardholder. NPC registration (\$125.00) will be available Friday night March 23rd, 2018 at weigh-ins/registration. **MUST BE CHECK or CASH**, Credit/Check Cards **CANNOT** be used. **YOU MUST HAVE** either your NPC card, or if you signed up online the verification with you. If not you will have to pay again as often we cannot verify NPC membership otherwise.

AGE DIVISION: Master's/Teen-Men/Women: Must have proof of age birth certificate, state ID, or driver license.

MUSIC: Bodybuilding, Classic Physique, & Women's Physique (WP) Music can be emailed or **MUST** be turned in at Check-in. Only classes that need 60 seconds of music are WP, Classic Physique, and Bodybuilding.

Please note length is 60 seconds (no exceptions), your music should be the ONLY track on the CD or Zip drive. Music is to be in good taste, vulgar music will be replaced with house music. It is not acceptable to present a CD with multiple tracks and suggest playing track 5, 34 seconds in. All music must be iTunes compatible.
